TM AND MIMOS TO COLLABORATE ON FOUR FRONTIER TECHNOLOGIES

MIMOS Technology Platforms to Enhance TM's Services to Its Customers

Telekom Malaysia Berhad (TM) and MIMOS Berhad (MIMOS) today signed a Collaboration Agreement on research and development activities, commercialization and potential technology transfer of grid computing, semantic, wireless access and Internet Protocol Version 6 (IPv6).

The 3-year agreement will enable TM and MIMOS to collaborate utilizing the following technologies:-

a. Grid Computing

TM will provide its Internet Protocol Virtual Private Network (IP VPN) service over the 1Gigabit METRO.e infrastructure which connects to Knowledge Grid Malaysia. METRO.e is an existing TM service for business customers based on the high-speed, fibre-based Metropolitan Area Network.

b. Semantic

MIMOS will provide Semantic Search (search by meaning) technology to improve TM's productivity.

c. Wireless Access

TM and MIMOS will explore the integration of TM's Streamyx Zone wireless connectivity with MIMOS' WiWi Gen 1.5, a hybrid solution which combines WiMAX and WiFi, to extend Streamyx Zone coverage.

d. IPv6

TM and MIMOS will push for the adoption of home-grown IPv6 technologies by indigenous industries.

Under the agreement, TM will further develop MIMOS technology platforms for commercialization in line with TM's customer demands.

The agreement was signed by Dato' Zamzamzairani Mohd Isa, TM Group Chief Executive Officer and Encik Azizi A. Hadi, Vice President, Retail Product on behalf of TM while MIMOS was represented by Dato' Abdul Wahab Abdullah, President and Chief Executive Officer and Encik Ahmad Helmi Abdul Halim, Director, Technology Portfolio Management.

Speaking at the signing ceremony, Dato' Zamzamzairani said, "The signing of this agreement today marks another symbiotic collaboration between TM and MIMOS and we are indeed proud that MIMOS has picked us as its technology partner and recipient. We really hope that the development of the technologies under this agreement will lead to more innovative and enhanced offerings by TM, fulfilling the future market needs."

"We are also developing an entrepreneurship program in relation to the commercialization of the technologies as TM is always in support of home-grown technology, especially for the benefit of our customer," added Dato' Zamzamzairani.

"Today marks another significant milestone for MIMOS as we transfer the frontier technologies from our laboratories to TM in line with our mission to grow globally competitive indigenous industries ultimately aimed at moving the Malaysia ICT industry up the value chain," said Dato' Wahab.

"Our collaboration with TM is testimony to the uptake and adoption of MIMOS' technology platforms and a further demonstration of how MIMOS is building up the technology eco-system to address the market needs and demands," added Dato Wahab.
